### **NEWS FROM THE NETWORK**

### Report from the 2<sup>nd</sup> Annual Conference

The second Annual LISBOAN Conference took place in Brussels on 10<sup>th</sup> and 11<sup>th</sup> May 2011. The topic that served as this year's thread was "Governance in and of the Crisis - Lessons and Options".

### WP I: "The EU's Institutional Framework Post Lisbon" (WP leader: Edward Best)

Variable geometry, multiple methods: can the institutions keep their balance?

The working group discussed the EU's institutional framework post Lisbon focussing on differentiation and its impact on the EU institutions. Several EU practitioners such as Richard Corbett (Cabinet of the President of the European Council), Antonio Missiroli (Bureau of European Policy Advisers), and Rafal Trzaskowski (European Parliament) analysed this topic referring to the current Euro crisis. Inter alia, it was argued that the EU institutions had increasingly come under scrutiny of markets. However, on a related note, speakers considered that the more dominant position of the executive due to the crisis had to some extent cancelled out the improvements in terms of democratic legitimacy achieved through the Lisbon Treaty. Brendan Donnelly (Federal Trust) as discussant completed the speakers' contributions with his

thoughts on the intertwined futures of the euro and the EU. [more...]

### WP III: "Economic and Financial Policy" (WP leader: Andras Inotai)

Over at last? Prospects for restoring economic stability in the eurozone and the EU

The debate of the working group was based on the initial question "Over at last? What are the prospects for restoring economic stability in the eurozone and the EU". Andras Inotai (Institute for World Economics) gave an introduction to the topic, followed by first statements of the panellists including Cincia Alcidi (Centre for European Policy Studies), Iain Begg (London School of Economics) and Zsolt Darvas (Bruegel), who contributed on past and possible future developments, economic stability and structural divergences, respectively. In the general discussion, the participants also included a view on the role of single member states and made reference to the situation in the US. [more...]

# WP IV: "The Lisbon Treaty in a courte, moyenne and longue durée perspective" (WP leader Wilfried Loth)

Crises in EU history: Lessons of the past?

Starting with the presentation by Michael Gehler (University of Hildesheim) that was entitled "Challenges and Opportunities. Surmounting Integration Crises in Historical Context" the working group dealt with the understanding and comprehension of the dynamics of European integration as a consequence of rifts and breaks and the results of crisis experiences. During the session, chaired by Wilfried Loth (University Duisburg Essen), the group had a closer look at past crises, but also linked former experiences of crisis to the current situation. [more...]

Teaching the Lisbon Treaty: perspectives from different disciplines

Kunstein (University of Cologne) and Alejandro Ribo Labastida (College of Europe) discussed different teaching methods. The core contribution consisted of Ribo's presentation on his simulation course in EU external crisis management. [more...]

### WP VI: "External Action and CFSP" (WP leader: Ian Manners)

Researching and Teaching EU External Action Post-Lisbon

The working group led by Kennet Lynggaard (Roskilde University) dealt with research and teaching of European Union topics related to External Action and CFSP. After a brief introduction in terms of content and relevance, the group discussed fundamental approaches and exchanged ideas related to basic concepts and methods in research on the EU in general and EU external relations in particular. ### WP VII: "Quasi Constitutional Nature of the Lisbon Treaty" (WP leader: Lucia Serena Rossi)

Assessing the quasi-constitutional nature of the Lisbon Treaty

The working group was dedicated to the assessment of the quasi constitutional nature of the Lisbon Treaty and future impacts on the issue of solidarity in the context of European citizenship and fundamental rights. The introductory remarks of Jean-Paul Jacqué (TEPSA) dealt with the EU's legal framework and its path towards a constitutionalized system. He stressed that the safeguarding of human rights did not require the legal or political structure of a state. The subsequent debate focused on the exact boundaries of applicable EU citizenship law, and also touched upon the issue of solidarity enshrined in Article 222 TFEU. [more...]

### **Awards**

LISBOAN offers annual awards for excellence in teaching and research with a view to the Treaty of Lisbon, each of which is endowed with a prize of EUR 1.500. This year's award ceremony took place during the second annual conference in Brussels on 11<sup>th</sup> May 2012.

**Alejandro Ribo** (College of Europe) and **Bruno Scholl** (College of Europe) received the Award for excellent teaching for their simulation course in EU external crisis management.

Sarah Wolff, teaching fellow at University College London and senior associate research fellow at The Netherlands Institute for International Relations, Flora Goudappel, associate professor at Erasmus University Rotterdam, and Jaap de Zwaan, Professor of the Law of the European Union at the Erasmus University Rotterdam, were distinguished for their publication "Freedom, Security and Justice after Lisbon and Stockholm" published in 2011.[more...]

### Workshop work package 6: External Action and CFSP

Enlargement Perspectives after the Lisbon Treaty

The workshop, which was organised by Atila Eralp (Centre for European Studies, METU) and took place in Ankara on 29<sup>th</sup> and 30<sup>th</sup> May 2012. Inter alia, the different panels discussed options for Turkey's relations with the Union against the background that classic membership to the Union no longer seems to be feasible. Other topics discussed include the success of support of structural reforms through the 'membership carrot' in the case of Croatia and the possibility to enhance the Union's soft power in candidate countries through more sectoral integration.

# Workshop: "The Cypriot EU Presidency 2012: Institutional consolidation and responding to new challenges"


The workshop was held in the framework of the Pre-Presidency Conference in Nikosia on 14<sup>th</sup> and 15th June 2012, which was organised by KIMEDE (Cyprus Institute of Mediterranean European and International Studies). cooperation with LISBOAN, the Trans European Policy Studies Association (TEPSA), the Cypriot Presidency of the Council of the EU, the European Commission Representation in Cyprus and the University of Cyprus. Main topics the participants dealt with were the Cypriot Presidency's priorities, the current economic and social crisis, free movement, external action and enlargement, always regarding the changes brought about by the Lisbon Treaties. The second PhD School was again organised in cooperation with the European Consortium for Political Research (ECPR) and took place in Lisbon from 18-30 June 2012.



On behalf of the LISBOAN network, Geoffrey Edwards (University of Cambridge and Workpackage Leader PhD Schools) and Kennet Lyndggaard (University of Roskilde) were lead organisers, closely cooperating with Tobias Schumacher (ISCTE-IUL), the local host of the event. 20 Students from all over Europe presented their PhD projects and attended lectures from 19 more senior academics. Lively discussions on academic topics during the day were oftentimes continued over a drink in on of the bars of Lisbon's Bairro Alto. Participants greatly appreciated the opportunity to discuss their research with renowned scholars in a relaxed atmosphere.

### Midterm Assessment by EACEA



In line with the Grant Agreement, the University of Cologne as the coordinating institution of the network submitted an 18-month progress report to the Education, Audiovisual and Culture Executive Agency in April 2012. The project was subsequently evaluated by the EACEA and an independent expert. Overall it received 7 out of 10 points, resulting in the release of the second pre-financing. While generally commending the project's activities, the evaluation report also stressed the need to involve as many network partners as possible.

### **UPCOMING LISBOAN EVENTS**

### Workshops

Three LISBOAN partners will organise workshops this autumn in the framework of work package 3 "Economic and Financial Policy" and work package 6 "External Action and CFSP", respectively:

On 28<sup>th</sup> and 29<sup>th</sup> September 2012, the Institute of World Economics will hold a workshop in Budapest on "*The European Union in the Global Economy*". Four panels will deal with the following topics: i) Strong and weak points of the EU in the rapidly changing global environment; ii) The European Union facing competition from emerging countries, iii) Crisis, challenges and policy responses of the Eurozone; and iv) The EU facing selected economic security issues.

The Institute for International Relations Zagreb will organise a workshop in Dubrovnik on 5<sup>th</sup> October on "The Impact of the European External Action Service (EEAS) on the EU's relations and policies towards South East Europe (SEE)". Questions which the workshop will deal with include: how can the Lisbon Treaty and EEAS actions contribute towards advancement of the enlargement process in the SEE region? How does the EEAS influence traditional interlinkages between the EU enlargement policy and the CFSP in the SEE? What are Croatian expectations for its active participation in the EEAS?

On 18<sup>th</sup> and 19<sup>th</sup> October 2012, a workshop in Berlin held by the Institut für Europäische Politik will deal with "The EU as a Foreign Policy Actor - Ambitions, Interests and Challenges in Year Three of the Lisbon Treaty and beyond". More details will be available soon.

#### Save the date

A fourth workshop is planned for 14-15 November 2012. This event, organized by the Centre for Interdepartmental Research Centre on European Law, will deal with the quasiconstitutional nature of the Lisbon Treaty.
